#### **Keynote presentation**

Richard Welford made an interesting presentation on Corporate Social Responsibility in Asia. (Presentation available).

Main points of interest:

- China is three times the size of the EU (world-wide it is the second largest manufacturer of finished products and second largest importer or oil)

- The new Chinese middle class is about 140 mio people and about 10% of the population can now afford a car.

- In Asia CSR is often driven by external factors

- There are serious challenges to ensuring that ethical standards are upheld in supply chain management

- Multinationals and large companies are themselves having to police that laws are enforced (the laws are correctly in place in most cases but not enforced)

- There is general wide spread support for CSR at governmental level in China

# Short introductions

Manuel Barriga - TMB

- Operates both metro and bus
- 6300 employees
- Main focus of approach is on CSR (Corporate Social Responsibility)
- Human resources department focus on accessibility
- 100% accessible on rail services by 2008 and all 1100 buses are already 100% low floor (2006).
- Other actions include procurement, ethical codes, plan of action for increasing sustainability e;g. use of natural gas.

# Didier Tournot -RATP (Paris)

- Main focus of activities for sustainable development centres on energy use, reduction, alternatives and management as energy represents 10% of RATP's turnover

- Managing waste and water are also high on the agenda, in particular and recently they have been working on reducing their use of paper in the organization from present levels of 900 tonnes a year

#### Dominique Delis - Veolia

- Veolia Environment group has four main divisions – water, waste, energy & transport and operates in 27 countries

Has created their own 7 point charter to help increase awareness across the world in all the different sites

- publishes sustainable development report (2006)

- present focus on the collect of data and the development of sustainable indicators from 104 priority sites world wide (eventually from 741 networks). This data mainly covers environmental aspects – waste management; water use; fuel/ energy; environmental audit etc

- special attention is presently being given to the social aspects in terms of special indicators from Human resources

- economic impact – looking into the feasibility of creating a model that shows avoidance of CO2 and carbon neutral aspects of collective passenger transport.

#### Johan Nordgren – SLTF (Swedish Public Transport Association)

- represents 21 public transport authorities

- Increased attention to this topic
- Environment working group has been going for some time but recently intoriduced a climate change working group

- On a national basis, Sweden is taking CC seriously and has a oil commission headed by the prime minister to ensure that Sweden reduces its dependence on fossil fuels.

# Micheal Schemmer – Bombardier Transportation

- Focussing on the product side
- Following ISO standards and EMAS (Eco- environmental Management Audit System) European standard
- Lowering energy use in manufacturing
- 1<sup>st</sup> independently verified sustainable development report will be published in late 2006 (to add to the Health, Safety and Environment (HSE) report already published)
- Looking at reducing the environmental impact of the whole product life cycle

#### Glenn Frommer - MTR Ltd Hong Kong

- Working on environment for past 15 years and n ow considered a leader in the region
- participates in several local and regional bodies on Corporate Social Responsibility and Sustainable Development

# 6 List of signatories

#### Decision

#### <u>3 Climate change working group</u>

See draft paper (NB UITP has a European Position on Energy and Climate change and this will complement it on an international level) First draft of position to be circulated as soon as possible (prepared for comments)

There had been some considerable discussion on the Fuel position prepared by the Bus Committee at the last Policy Board and it had not been a smooth approval process.

A background paper and the draft should be circulated to other commissions and committees to ensure good support at the Autumn Policy Board meeting.

#### Decision

- First comments by August 15<sup>th</sup> (to be sent to key Commission chairs for their approval and the members of the Policy Board that wished to be informed)
- Second comments by September 10<sup>th</sup>
- Background paper to be prepared for the Policy Board so they fully understand the content, the methodology and preparation of the position and the marketing plan

# 8 Bilbao Conference

The Conference starts on the 18th and is preceded by a study tour that starts in London on the 13th October and finishes in Bilabo on the 18th October.

Much discussion on a possible keynote speaker (one has now been found – Hank Dittmar – see CV)

All Members of the Commission are expected to help with the marketing of the event and the Study tour. It is expected that they will attend at least the conference and if possible the study tour.

Whenever possible either bio or fair trade products would be used but this doubled the costs and therefore the events department could not commit to this
